This Agreement is made and entered into by and between the Ocala International Horse Show (OIHS) and

The Commercial Vendor hereby agrees:

1. The Commercial Vendor will lease vendor space during the OIHS being held October 26-30, 2021 at the World Equestrian Center (WEC), Ocala, Florida.
2. OIHS Management will select exhibit locations and will assign Commercial Vendor locations in its sole discretion, and may make such changes as needed for deemed necessary.
3. OIHS and WEC will not be responsible for any loss, personal injury, nor for damage to Commercial Vendor or for any property of any kind or nature that may be lost, destroyed, or damaged.
4. Each Commercial Vendor shall be responsible for injury to any person or damage to any property while on WEC property, whether caused by any product owned, provided by, or sold by Commercial Vendor or any action or activity of said Commercial Vendor, its agents, or its employees.
5. Commercial Vendor shall indemnify and hold harmless OIHS and WEC against any and all claims or damages, of any kind or nature, that may arise from any injury or damage that may occur or be occasioned by any action of said Commercial Vendor, its agents, or its employees, or any product sold or provided by said Commercial Vendor.
